## **YOUTH COMMITTEE DEVELOPMENT:**

Shannon discussed some of the work that could happen under a Youth Committee, such as looking at ways to better serve and reach out-of-school youth, which would better align services based on the priorities under WIOA. In addition, the Youth Committee could work on some of the career pathways initiative as it relates to youth and workforce development.

- Foster Care Representative;
- Jobs for Montana Graduates Representative;
- SWIB Representatives;
- K-12 Education Representative;
- Adult Basic Education Representative;
- Alternative Education System Representative;

- Homeless Youth Provider Representative;
- Job Corps Representative; and
- Corrections Representative.

Ms. Lee moved, and Ms. Harrington seconded a motion to form a Youth Committee under the Education & Training Committee.
