SERVICE PROVIDER SELECTION AND PROVIDER AGREEMENTS POLICY:

Ms. Harris walked the Committee through the Service Provider Selection and Provider Agreements policy and answered questions about the policy to members of the committee.

Mr. Minto moved and Ms. Blumenthal seconded a motion to approve the Service Provider Selection and Provider Agreements Policy. The motion carried.

ONE-STOP CERTIFICATION TEMPLATE:

Ms. Lewis walked the committee through the One-Stop Certification Template and discussed the certification process for the state of Montana's one-stop system. The template was designed using guidance from the U.S. Department of Labor and includes all the WIOA criteria for certification of the one-stop system. Mr. Minto asked that the ranking for each site standard read as follows:

5=exceeded standard 4=achieved the standard and excelling 3=significantly meeting standard with some work yet to do 2=have some of the elements in place, some of the time 1=making progress, but have a long way to go *Mr. Minto moved and Mr. Hopfauf seconded a motion to approve the One-Stop Certification Template as amended. The motion carried.*
